

ENVIRONMENTAL, SOCIAL AND GOVERNANCE STATEMENT

All reports are treated with the utmost seriousness and confidentiality, with a clear non-retaliation policy to protect those who come forward. We are dedicated to thoroughly investigating all claims and taking corrective action where necessary.

Diversity and Inclusion: We strive to promote diversity, equity and inclusion at all levels of the company, with a commitment to gender, racial, and experiential diversity. By working to include a variety of perspectives, experiences, and backgrounds, we aim to reflect the communities we serve and foster more inclusive decision-making.
